For DBA module duration varies from 74 days to 90 days.

Convocation	On completion of IMBA and DBA, successful learners will be invited by the respective Universities (GMU, Spain& UCAM, Italy) to attend the convocation. Note: Travel & Stay not included in course fee – attending convocation is not Mandatory.
